Pilot Declaration

I hereby certify that I have read, understand and will fully comply with local procedures and operations as specified by the newest version published on the JWGC 2022 competition website of Selfbriefing, Local Procedures and daily briefings.

I certify that I understand and will comply with all the regulations and requirements set out by FAI Sporting Code, Section 3 and Annex A. I certify that I fully fulfil all the requirements to fly and compete throughout the competition as set by Annex A and all applicable local and EU laws and will notify the competition director immediately if this changes, this includes ICAO English certificate to communicate in English.

I confirm I know and will abide by the rules set out by the World Anti-Doping Agency (WADA) and will inform the competition director of any Therapeutic Use Exemptions (TUE) I hold not later than at registration.

I confirm that the aircraft I will be flying meets all the requirements for flight as set out by FAI, EU laws and any applicable laws from the airplane's country of registration and agree that the airworthiness may be checked by technical inspection upon the decision of jury, steward or the competition director at any point during the competition. I will notify the competition director immediately of any changes to the airworthiness of my glider.

Throughout the competition I will follow all applicable EU laws, both in the air and on ground, acknowledge that the safety of me, other pilots and other people is at the utmost importance and in all my actions I will act to ensure the highest safety standards. I confirm I have insured my glider to the minimum third-party liability amount as specified by Local Procedures or applicable EU laws, whichever is higher, in the whole region of the competition area (Czechia, Austria, Germany and Poland) for the full duration of the competition.

I confirm I hold a valid personal medical insurance for the duration of the competition, and I certify that all my crew and family members are also fully insured in the EU area. I understand that the competition organiser, Aeroclub Tábor or any other person involved in operations on the airfield holds no liability to any damage or harm I, my crew or family or my property may suffer during the competition and that participating at the competition is entirely at my own risk. The organiser is also in no way responsible to any damage or loss of property at the airfield. I accept full responsibility and liability for any damage or harm caused by me, my crew or family or my property and will promptly repay any damage/harm caused.

In accordance with the General Data Protection Regulation (GDPR) and corresponding local legislative I give permission to the competition organiser to store and process my personal data provided during registration for period not exceeding for two years and share it with the FAI or other official agencies as required. I acknowledge that the personal data will be processed for the public relations purposes (as described below) including presentations in media, supervision of compliance with sporting, safety and general aviation rules. I give permission to the organiser to publish my location data provided in flight recordings publicly on Soaringspot in accordance with Naviter/Soaringspot privacy policy. I give permission to the organiser to publish photos from the competition which may include photos of me, my crew and family members. These photos may be shared with FAI, Aeroclub of the Czech Republic, AirzoneTV and their partners for promotional purposes of the competition and air sport.
